Owosso Speedway reserves the right that ALL drivers/team owners are REQUIRED to sign a no traction control compliance agreement informing drivers and teams that traction control is not allowed. Penalties will include but are not limited to suspension/fine. The fine amount, to be determined, if a team is caught with traction control will go to the driver or team owner. The driver or team owner will forfeit ALL parts of the traction control system, not limited to: controls, switches, distributor box, wire harness, etc. The traction control items will become Owosso Speedway property. Traction control items that were forfeited will remain Owosso Speedway property with NO option of being redeemed by the race team.
